

Walker and Bill Brown read, as a chorus, the names of all 499 men and women commemorated on the panels of the memorial. The Association of Oldest Inhabitants of the District of Columbia (AOI) held the eighth luncheon meeting of its 153rd year at the Capitol Skyline Hotel at Noon Friday, Nov. 16, 2018 with 51 members and guests present. This was the final meeting of the 2018 membership year. President Bill Brown welcomed the attendees and called for approval of the notes of the October meeting, which were printed in the current newsletter. With no further corrections or additions, a motion made by **Joan Gibala** and seconded by **Patricia Clark**, the notes were approved and their reading waived.



Vice-President's Remarks: Bill welcomed everyone and in addition to spouses and family members:

Alex Sastov was Juliette Smith's guest; Dwane Starlin had with him Marilynn Bennett; and Patricia Clark had Elizabeth Burke and Gabor Konkoly-Thege joining her.

Brief Announcements: **Vice-President Brown** remarked how successful and well-attended our joint observance of the Armistice was with the D.C. National Guard on November 11th – Armistice Day/Veterans Day -- and motioned to indicate the series of photos being projected throughout the business meeting portion of the program.

Bill was pleased to announce that after many years of neglect and deferred maintenance that Holy Rood Cemetery (35th Street and Wisconsin Avenue, NW) has been the beneficiary of an agreement between Holy Trinity Parish and Georgetown University that provides for more than \$800,000 in deferred maintenance and improvements and grants Holy Trinity an easement that will allow it to build a columbarium there for parishioners and others. They've produced an informational brochure on plans for restoring the cemetery, on sponsorship opportunities, and on how to purchase a columbarium niche. Their goal is to have the columbarium and cemetery restoration completed by All Souls Day, November 2, 2019.

Bill also called to everyone's attention that member **Skip Moskey** contributed to the fall issue of "White House Quarterly" with his article on President Wilson's trip to Europe for the treaty-signing after the war. You may want to check it out or subscribe.

Prior to introducing the day's speaker, Bill was asked to relinquish the lectern and microphone to AOI Secretary **John Richardson** who, together with Director **Carl Cole**, asked to say a few kind and flattering words about Bill Brown's leadership as President during his tenure.

The Day's Speaker: John Kelly, "Washington Post" writer of "John Kelly's Washington, "provided a fascinating look into the District's "Lost Laws," statutes passed in 1872-1873 to provide equal access for blacks and whites to restaurants and other public accommodations. The laws were steadily ignored/bypassed with the end of Reconstruction and were not resurrected until the 1950's, when African-American civil rights activists challenged implementation all the way to the Supreme Court, which upheld the laws' validity. (The argument was made by civil rights opponents that the laws had literally been lost, but copies were readily found in more than one location.) As Jim Crow descended on the country from the 1890's, brave individuals continued to make legal challenges that became part of the eventual confirmation that the laws had never "gone away." Kelly noted that the late Ben Bradlee, who ran the Washington Post under Catherine Graham, was a young reporter on the (then) Metro section of the paper and covered the story as it broke. Kelly also noted that E.M. Hewlett and Robert H. Terrell, two black attorneys who personally challenged restaurant segregation, were later appointed District judges.

Carl Cole, a multi-generation native of Southwest, recounted family stories, one in particular that his grandmother opposed school integration because their black teachers were generally better educated than the whites, and

she feared a drop in black educational levels once the black teachers were sidelined after 1954 and "Brown vs. Board of Education," which finally destroyed school segregation in the United States.

The next AOI luncheon program will be Friday, February 15, 2019 when Stewart and Lynetta Stevens will tell of Stewart's decade's long occupation of "chandelier cleaner" and window-washer at the White House. Also, we hope to see many members at our annual New Year's Day brunch buffet on Tuesday, January 1, 2019.
