President's Message... A Rededication, Reminiscence and an Award:

On Saturday, May 28, 2011, the Battleground National Cemetery (a few blocks from Ft. Stevens) was rededicated after extensive renovations were made possible by American Recovery & Restoration Act Funds. Rock Creek Park Superintendent Tara Morrison presided over the ceremony which featured remarks by Council Member Muriel Bowser



and Tersh Boasberg, President of the Alliance to Preserve the Civil War Defenses of Washington.



An Honor Guard presented the colors, the National Anthem was sung, Chaplain (Maj.) Sellers of Walter Reed said a prayer of dedication and Taps was played. (Cont'd. on Page 3)

If You Were Not At Our May Meeting ...

The fourth luncheon meeting of the year was held at the Channel Inn on May 20. President Bill Brown presided, with 90 members and guests in attendance.

President Brown asked if there were any additions or corrections for the minutes. None being offered, Bill called for a motion to approve the minutes, noting that in so doing we would dispense with their reading. That generated enthusiastic approval of the motion, which had been made by **Bob Proudley** and seconded by **Joe Grano**.

Bill announced that four new applications for membership were received since the last meeting. The applicants are **Evelyn Christian** (who is the mother of member **Anita Lee**. Evelyn will be 97 on June 1, and may become the oldest Oldest Inhabitant; also **Herb Mintz** (nominated by George Hutchinson); and **General Thomas Camp, Jr**. and **Margaret Camp** (both nominated by Jan Evans Houser). A motion for accepting the applications was made by **Carl Cole**, seconded by **Al Wheeler**, and quickly approved.

Treasurer **Hulit Taylor** reported on our membership data and our financial picture. With the new members accepted today we have over 300 in good standing. Of these, 30 have joined this year. Hulit reminded members that those who have not renewed by the end of June will be placed on the inactive list and will not receive the Newsletter or other mailings. Income from both dues and contributions is on track, and there were no nonroutine expenses in April. The value of our investment account is now more than \$190,000. Bill introduced new members, first timers, and guests.

AOI Historian Nelson Rimensnyder made announcements regarding forthcoming activities that will commemorate Civil War sesquicentennial events, and provided background information.

Our guest speaker for the today's program is James H. Johnston. He is a lawyer who has performed historical research on the Loughborough family of Washington. He has written a book based on the document "Margaret Cabell Brown Loughborough Recollections" which is in the Maryland State Archives dated November 1912. That document forms Chapter 3 of Johnston's book, which provides the background and commentary needed to understand this history. The speaker's presentation was extremely interesting, well illustrated, and easy and enjoyable to follow. It introduced many well known Washington figures into the history of the Loughborough family, while Margaret Loughborough's observations only covered the four years of the Civil War. Much information was gleaned previously from her personal diary, which unfortunately seems to have disappeared in the 1960's. Johnston is to be commended for his efforts in tracking down and sorting out an intriguing history, and in providing valuable analysis and perspective for current understanding. It should be noted that the publisher's title and author's listing for the book is "The Recollections of Margaret Cabell Brown Loughborough: A Southern Woman's Memories of Richmond, VA, and Washington, DC, in the Civil War," by Margaret Loughborough and James H. Johnston.

President's Message (Cont'd)...

Battleground National Cemetery was dedicated by President Lincoln in 1864 to honor the 40 Union soldiers killed at Ft. Stevens on July 11th & 12th. The last surviving veteran of the Battle of Ft. Stevens was buried there in 1936 bringing the total to 41. With the rededication of the cemetery and restoration of the Superintendent's Cottage (designed by Montgomery Meigs) another step has been taken to help preserve the District's ring of circle fort parks which comprise the Civil War Defenses of Washington. Park Ranger Alexa Viets will up-date our members and guests with plans and recent accomplishments to "re-connect" these forts by trails and new interpretive signage.

But many AOI members will recall a field trip in June 2002 when Past-president Phil Ogilvie conducted a bus tour of some of these featured sights including Battery Kemble, Fort DeRussy, Fort Stevens, Battleground National Cemetery, the Armed Forces Medical Museum and, finally, the African-American Civil War Memorial. The day featured a presentation by Donise Williams portraying Elizabeth "Aunt Betty" Proctor Thomas whose home was seized to make room for Ft. Stevens.

Now, nine years after that field trip, the AOI has awarded its 11th annual Dr. Philip W. Ogilvie Award to Jill Talladay at a reception May 14th for the George Washington University graduates of the Advanced Masters of Tourism Administration program.
