#### President's Message...

**Reenactor** (rē-ĕ-**nak**'-tĕr) *n.*, a person who participates in reenactments of historic events...

Since I first saw Donise Stevens portray Mrs. Elizabeth (Aunt Betty) Thomas as the owner of the property seized for the site of Ft. Stevens, I have been intrigued by historians, guides, Park Rangers and enthusiasts who have taken on the role of an historic personality to bring history to life. Ms. Stevens' account of President Lincoln's promise to return Aunt Betty's property after the Civil War was a highlight of a Civil War tour arranged by AOI's past-president Dr. Phil Ogilvie for us back in 2002.

AOI members may recall the superb interpretation of Frederick Douglass by Michael Crutcher at Civil War symposia and other events sponsored by the Military Road School Preservation Trust. I have even tried my hand at reenacting by portraying past DC Police Chief and AOI Vice-president Ernest W. Brown as he recounted crimes, unrest and disorder in late 19th century Georgetown.

This month AOI members Patricia Tyson and Joyce Bailey will be joined by Theresa Saxton and their fellow reenactors of FREED (Female **REE**nactors of **D**istinction) to present our members and guests with their portrayal of African-American women of the Civil War era.

Living history is a means by which students, enthusiasts and devotees of historic periods bring the events and people of different eras to 'life' for visitors and other students of history. We appreciate and enjoy the efforts of reenactors to research and portray these characters from our past.

# If You Were Not At Our April 2010 Meeting...

The third luncheon meeting for this year was held at the Channel Inn on April 16. President Bill Brown noted that this is our 145th year. There were 86 members and guests attending.

A motion to approve the minutes as printed in the newsletter was accepted.

Bill announced that there were many applications for new memberships since the March meeting. This was partly due to the interest generated by John Kelly's recent column in the Washington Post. Of the 13 applications, 9 were as a result of the Kelly article. The new applications were for: Ann McClellan (last month's speaker); Marion Redlich (learned of AOI at the Franklin School roundtable); Barbara Plummer (nominated by Bonnie Duncan); and Alice Kelly (nominated by Leslie White). The applications due to the Kelly column are for Robert H. Griffith, Gary Alston, Dianne Anderson, Daniel Harris, Judson MacLaury (who lives in Seattle, Washington), Charles Sharp, Michael Townshend, Dr. Albert Zanner, and Capt. Frank N. Hannegan. A motion to accept the applicants as new members was made by Carl Cole, seconded by Anne Renshaw, and approved by

Bill noted the passing of former members **Louise Grass** and **John Jurney**.

Treasurer **Hulit Taylor** presented a brief report. There

are 304 paid-up members. Income from member dues and member contributions are up compared to last year. Recent disbursements include \$500 to George Washington University for the Phil Ogilvie award, \$100 to the Committee of 100 (dues), a deposit for the Shepherd statue plaque was placed. Over the past 5 years members' contributions are sufficient to pay for the plaque. Our investment account increased in value by approximately \$8,500.

Bill introduced first timers and guests and discussed other meetings of interest to our members.

Our speaker today was AOI member **Dr. Mark N.** Ozer, who is the author of "Washington D.C. Politics and Place: The Historical Geography of the District of Columbia." Although he is a professor of neurology, he was extremely interested in the growth of cities, and after moving to Washington in 1964 he soon found himself teaching a course in Capital history. Mark presented a very interesting illustrated tour of the interaction of history and politics in DC, starting with the 1790's up to the present time. He has stressed answering questions of Who, Why, What, Where, and When in his overview of the development of the national capital. His views offer different insights regarding the motivating forces in the growth of DC. For example he considers that the most important building built in DC after the Civil War era was the State, War, and Navy Department Building. The reason for this belief is that this construction was a commitment by the government to maintaining Washington DC as the seat of government executive departments, at the time when political power was being brought to move to St. Louis. Mark's lecture was replete with many such insights. The audience very much enjoyed the presentation, which frequently displayed his erudition as well as his humor.

### Historic Mount Pleasant Applies to Humanities Council for Grant, Seeks AOI Members' Reminiscences and Recollections...

Mount Pleasant has been a designated historic district under D.C. Law 2-144 since 1987. Historic Mount Pleasant proposes to research and document the evolution of both its physical and commercial features and to place these developments within their broader historical context. Information from building permits, including original drawings, will be compiled along with the identities of individual property and business owners and the nature of business conducted at particular locations and their dates of operation. The distinguishing architectural features of the buildings will be identified and described. Residents and former residents of the neighborhood will be invited to provide personal recollections of interactions with Mount Pleasant businesses.

The primary goal is to educate and inform both merchants and residents of the rich history in their midst, hopefully inspiring a respect for the architectural heritage and informing revitalization plans. The current condition of the commercial corridor is an issue of utmost concern to many residents of the neighborhood. In addition to alterations that obscured or obliterated architectural details, buildings have long been allowed to deteriorate, to the point where in many cases the original appearance is not apparent. Further, recent fires and business closings have created dead spaces along the street.

HMP has informed the Mount Pleasant Business Association and Mount Pleasant Main Street of its intention to undertake this research and has also obtained the agreement of the Association of Oldest Inhabitants (AOI) to publicize these activities through its network and provide a letter in support of the grant application.

While volunteers assist with the historical research, HMP will publicize their efforts by visiting businesses and showing them primary source material for their locations as it is identified and copied. Distribution of the pamphlet in the fall will be made by personal delivery to the businesses, and several will be selected as points of distribution for the pamphlet. The pamphlet will announce the availability of the research paper on our website. Hard copies of the research paper will also be placed in the HMP file at the Mount Pleasant Library.
