President's Message...

Memorial Day and the D.C. War Memorial

For 76 years, the D.C. War Memorial Corporation has held its commemorative event the Sunday before Memorial Day at the D.C. War Memorial. Last year I was asked to provide remarks. This year I was advised by Thomas Kouyeas, the organization's director, that due to 'sequester'-imposed cuts to the Park Service's budget, NPS would not be able to provide support for the event and the corporation could not afford to cover the expenses. Hence, there will be no 77th official observance of Memorial Day this year. This is truly a shame; however, we should not allow this turn of events to deter us in our remembrances of those brave sons and daughters of the District who gave their lives in the Great Conflict.

If You Were Not At Our April Meeting...

[Draft minutes of our last meeting for approval at the May 17th 2013 luncheon.]

AOI held its April 2013 meeting at the Pier 7 restaurant of the Channel Inn on April 19, 2013. **President Bill Brown** welcomed the 96 members and guests who were attending to the third AOI luncheon of its 148th year.

The draft of the minutes of the March meeting was considered for approval. No additions or corrections were noted. **Austin Kiplinger** moved, seconded by **George Hutchinson** to accept the minutes as presented in the newsletter. The motion was approved.

Six new applications for membership have been submitted since the last meeting. The applicants are **Judy Back** (nominated by **Grace Heitmuller**). Judy in turn recruited her friends **Dorothy Hartland** and **Mary Scott** to sign up also! **Doreen Conrad** was nominated by **Gary Scott**. **Charles Robertson** was nominated by **Anne Sellin**. Bill noted that Charles is Anne's brother. **Nancy Starr** was nominated by Barbara Bates. **Robert Proudley** moved, seconded by **Helen Tsintolas**, that the applicants be accepted for membership. The motion was quickly approved.

Treasurer Hulit Taylor presented her report. There are currently 314 members, which is consistent with data from past years. Hulit discussed our Ogilvie Award, which has presented an AOI grant to the outstanding student in the Masters in Tourism program at George Washington University for 11 years. Phil Ogilvie was an outstanding president of AOI and an adjunct professor in the GWU tourism program. Subsequent to his death the grant was renamed in his honor, and has been supported by AOI member contributions. The AOI Board recently voted to increase the stipend to \$750 from its former \$500 amount.

Hulit discussed a change in our newsletter operation and its contractor. The firm of GRC Direct will handle its printing, addressing and mailing at favorable competitive rates, and this will relieve Bill of many hours of labor which he spends in order to produce the newsletter in a timely and cost saving manner. The new contractor, in addition, emplaces helpful tabs which keep documents from unfolding while being handled in the mail. The new procedure will save time and be more cost effective when all labor is considered, i.e. Bill Brown and his wife have been addressing, stamping, and mailing the newsletter with considerable and diverse personal effort. This effort will now be provided by the contractor. Our total

newsletter costs, including these new duties, will increase our cost approximately \$100, but provide relief for the personal labor (including much "gopher" time) donated by our conscientious, overextended, and uncompensated staff of Browns.

Our investment account continues to do well and now has exceeded \$1,400 this year in dividends and interest.

Bill told us of the recent deaths of three important AOI members. They were all active in AOI and their lives lead us to celebrate them as well as to mourn their passing. **Father Michael O' Sullivan** died March 11th. He was 81 years old, attended our meetings frequently, and tended his Capitol Hill Catholic parish with intense devotion. The Washington Post bio is fascinating. **John M. (Jack) Wigglesworth** was 99 years old, also died March 11th. He would have been 100 on April 12th. He worked for the CIA and retired in 1973 after 23 years with the directorate of intelligence. He founded a travel agency after retirement. **Evelyn Christian** passed away April 12th. She was 98 and left many children, grandchildren, and was a great-grandmother as well. Three exemplary lives, all passing away about the same time.

Bill introduced guests, offered announcements of possible interest, and informed us of new developments and plans for the historical society.

Historian Nelson Rimensnyder presented a trivia question. It dealt with the event at Griffith Stadium on April 17, 1953. What was it? It was opening day for the Washington Senators and Mickey Mantle hit a 565 foot home run out of the stadium. Member **Vince Scalco** was there that day, knew the answer to the trivia question and was presented a 'prize' by Nelson.

Our speaker for today was **Conrad Reid**. He was Executive Vice-President for Security Storage for many years. There is much history of our AOI interactions with Security Storage over the years, as that company took care of AOI's antique fire apparatus for considerable time. Today Conrad presented us with a truly unique talk, "Moving the First Families." In it he related historical anecdotes of some of the experiences of moving departing US President's possessions from the White House after their terms ended. Security Storage traces its founding to 1890, and has managed to secure contracts for the departing presidential moves mainly since then. They moved Woodrow Wilson, of course way before Conrad's time. When Conrad came out of the Marine Corps much later, Security Storage offered him a job, which he accepted, successfully working his way up to the Board of Directors after retirement. Part of the requirements for success in dealing with projects for the White House is the need for discretion in the handling of

information. This, together with the excellence in the physical aspects of handling and moving, established Security Storage as an important well qualified resource in this area. Conrad delighted us with many stories drawn from his experiences with these presidential moves. He very much enjoyed working with the first ladies at the White House since they were more involved with the actual logistics of these moves. Using that noted discretion he told us of his favorites --there were many, and the sometimes unusual demands of the job on his family and wife. All of these were delightful stories. Among his White House favorites were Barbara Bush, Lady Bird Johnson, and surprisingly Mrs. Agnew (not a first lady but vice presidents were also moved, including Al Gore and family). Conrad told of spending 7 days with Mrs. Johnson on their move; by then he was permitted to be on the resident floor (a higher security area) when a Johnson daughter came through with the brand new grandchild. Turning to Conrad, she said "Here, hold this" and Conrad reacted fearfully, moving to the nearest chair possible while praying that someone would come right away and take the baby from him. Someone did, but Conrad said that never stopped shaking from that. (Clearly he's a Washington mover and shaker). He continued on with many amusing events. He told of how Jimmy Carter rented a U-Haul to take away some of his personal papers, and parking it inappropriately close, only to find later that the Secret Service had towed it away. They had to tow it back! He continued with stories from the Nixon and Reagan moves, up through the Bushes. Conrad is a wonderful raconteur and relates these stories in a clear well timed manner. There was a very interesting Q&A session following the talk.

This was another extremely enjoyable program that presented a special learning opportunity.


