

**AMENDMENT TO H.R. 6364**  
**OFFERED BY MR. BISHOP OF UTAH**

Strike section 10 (page 15, beginning line 5) and insert the following new section:

1 **SEC. 10. ESTABLISHMENT OF NATIONAL WORLD WAR I ME-**  
2 **MORIAL IN THE DISTRICT OF COLUMBIA.**

3 (a) **AUTHORITY TO ESTABLISH COMMEMORATIVE**  
4 **WORK.**—The World War I Memorial Foundation may es-  
5 tablish a commemorative work on Federal land in the Dis-  
6 trict of Columbia and its environs to consist of an appro-  
7 priate sculptural or other commemorative elements to  
8 serve as the National World War I Memorial.

9 (b) **LIMITATION ON SIZE OF MEMORIAL.**—The Na-  
10 tional World War I Memorial may not exceed 0.5 acres  
11 in size.

12 (c) **COMPLIANCE WITH STANDARDS FOR COMMEMO-**  
13 **RATIVE WORKS.**—

14 (1) **IN GENERAL.**—Chapter 89 of title 40,  
15 United States Code, shall apply to the establishment  
16 of the National World War I Memorial in the Dis-  
17 trict of Columbia and its environs.

18 (2) **EXCEPTION FROM PROHIBITION ON ADDI-**  
19 **TIONAL COMMEMORATIVE WORKS IN RESERVE.**—

1 Section 8908(c) of title 40, United States Code, does  
2 not apply with respect to the selection of the site for  
3 the National World War I Memorial.

4 (3) NO INFRINGEMENT UPON EXISTING MEMO-  
5 RIAL.—The site selected for the National World War  
6 I Memorial may not infringe upon or adversely im-  
7 pact the District of Columbia War Memorial.

8 (d) LIMITATION ON TOTAL COST.—The total cost to  
9 design and construct the National World War I Memorial  
10 may not exceed \$10,000,000.

11 (e) DEPOSIT OF EXCESS FUNDS.—The Memorial  
12 Foundation shall transmit to the Secretary of the Treas-  
13 ury for deposit in the account provided for in section  
14 8906(b)(3) of title 40, United States Code—

15 (1) any funds that remain after payment of all  
16 expenses incurred in the establishment of the Na-  
17 tional World War I Memorial (including payment of  
18 the amount for maintenance and preservation re-  
19 quired under section 8906(b) of that title); or

20 (2) any funds that remain for the establishment  
21 of the commemorative work on expiration of the au-  
22 thority for the commemorative work under section  
23 8903(e) of that title.

1           (f) CEREMONIES.—The Centennial Commission may  
2 plan, develop, and execute ceremonies to recognize the es-  
3 tablishment of the National World War I Memorial.

4           (g) MEMORIAL AREA DEFINED.—In this section, the  
5 term “District of Columbia and its environs” has the  
6 meaning given that term in section 8902(a)(2) of title 40,  
7 United States Code.

Amend the title so as to read: “A Bill to establish  
a commission to ensure a suitable observance of the cen-  
tennial of World War I, to provide for the designation of  
memorials to the service of members of the United States  
Armed Forces in World War I, and for other purposes.”.
