We understand that change doesn't come easily, but one of our primary considerations was maintaining a venue in DC and our new host is located only 7 blocks from our previous location.





AOI held the second meeting of its 149<sup>th</sup> year at Pier 7 Restaurant Friday, March 21. 111 members and guests were on hand to hear Erin Bergin Voorheis speak about her recent book, "The Washington Arsenal Explosion: Civil War Disaster in the Capital," which represented completion of a work begun by her father, who passed away before publication.

The draft minutes of the February 2014 meeting were approved as distributed.

**Membership Report**: New member **Gene Fisher** (nominated by Nelson Rimensnyder) was approved by voice vote.


#### Treasurer's Report

-Brochures on the back table about the War of 1812 exhibit that will be at Anderson House (Order of the Cincinnati) until Sept. 20.

-Booklets on the back table commemorate the 150<sup>th</sup> anniversary of the Military School, of with which AOI is a supporter and heritage partner.

-Engine Company #29 (4811 MacArthur Blvd., NW) will be rededicated March 28, after extensive renovations.

**Nelson Rimensnyder** posed several trivia questions focused on Manny and Alma Fernandez, owners of the Channel Inn:

Where was Manny Fernandez born? (Spain) Why was Channel Inn's opening delayed by a year? (a fire)

Why did the Fernandez family leave Spain? (Civil War)

Where did Manny meet Alma? (Greenbrier Resort, W.Va.)

How did Mrs. Sweeney persuade the British not to burn Rhodes Tavern in 1814? (She said it was owned by a widow for whom it was the sole source of income).

The speaker today was **Erin Bergin Voorheis**, daughter of **Brian Bergin**, who worked for years researching and writing about a seldom-recalled Civil War disaster at the Washington Arsenal (now Ft. Leslie J. McNair) June 17, 1864 that resulted in the deaths of 21 women employed there making ammunition for the Union forces. As the son of Irish immigrants, Brian Bergin was drawn to the Arsenal tragedy since so many of the victims were women of Irish origin.

The explosion at the Washington Arsenal – entirely avoidable – was caused by natural combustion of fireworks material left in the sun to dry June 17, 1864 by the Arsenal director, Thomas Brown. The material exploded, sending sparks in all directions, at least one of which flew through the open window of a so-called "choking room" where rows of young women added lead bullets to cartridges containing black

powder and "choked" them closed. The boxes of completed cartridges were to be removed immediately because of their volatility, but due to the press of work, filled boxes remained in the choking room and added to the inferno when an errant spark from the drying fireworks ignited gunpowder on one of the tables where the young women worked. In the instant inferno caused by fast-spreading explosions, 21 female workers died and many more were injured. In a gesture of maturity and pride, the surviving women workers and other Arsenal employees not only arranged a dignified funeral procession but also raised \$3,000 for a stone memorial by sculptor and stonemason Lot Flannery that stands to this day over a mass grave in Congressional Cemetery. President Abraham Lincoln was chief mourner, although he did not speak. Arsenal chief Thomas Brown was censured and demoted but not fired. Congress appropriated \$2,000 for the victims' families.

...The design for the Randall school is by Bing Thom (the architect who designed the new Arena Stage building)." While the final mix of retail, residential and commercial is still being determined, the design promises to be exciting while maintaining Randall's façade (see below). During our visit to the hotel, we were pleased to see an exhibit featuring a local artist adorning the walls of the lobby.



A few things to keep in mind to make your first visit to the Capitol Skyline Hotel a stress-free one: **Directions** – if you usually come to the Pier 7 via Maine Avenue, rather than turning toward the waterfront on 7<sup>th</sup>, turn east on 7<sup>th</sup> and immediately bear right on I Street. Continue 6 blocks on I Street and make a right turn into the underground garage just beyond the portico. Don't inadvertently get into the line of cars waiting for the inspection station on Half Street! From I395 from VA, take the South Capitol Street exit and turn right onto I Street. From I395/695 south from MD, take I-695 to Washington Ave SW. Turn right onto Washington Ave SW, continue onto S Capitol St SW and turn right onto I St SW. The hotel has 2 levels of parking. If you cannot find a space in the garage, exit the ramp on the south side (not the

one you came in from) to their large, fenced-in exterior surface lot. From the garage, walk through the open door, through the vending area to the elevator lobby or just walk up a <sup>3</sup>/<sub>4</sub> flight of stairs (to your right) which takes you directly to the ballroom reception area. If you are traveling via Metro, of the two stations serving the area, the Navy Yard station is the closest; but, be extremely careful crossing South Capitol Street.



RSVPs: Our procedure for RSVP'ing will be the same as it has been; however, we need to provide the hotel our 'count' 72 hours in advance. So, the 'deadline' for RSVPs will be noon on the Tuesday (not Wednesday!) prior to Friday's luncheon. If you do not RSVP by the deadline, your food choice may not be available and it makes planning for both us and the hotel very difficult, so please... RSVP by the deadline. In order to accommodate us, the luncheon price will now rise to \$30/person (all inclusive). We regret this \$5 increase; however, as Board Member John Richardson recently pointed out, "I think we have just been jolted, albeit deftly, into 21st century restaurant prices." The actual luncheon cost is \$34, inclusive, but the Board has elected to ease the transition by underwriting \$4 per person for the remainder of this year.

Food Choices: The hotel's Assistant General Manager John Schumacher has crafted a unique menu for us helping maintain the variety of choices that we have enjoyed: *Grilled Skyline Chicken Breast, Grilled Black Angus Flank Steak, Sun Dried Tomato Pesto Crusted Flounder or Braised Ratatouille of Vegetables.* 

Again, the AOI Board appreciates your patience and understanding as we embark on this new luncheon meeting 'adventure.' We recognize there will be some 'bumps' along the way but we will strive to make our luncheon events as successful and memorable as always. We hope everyone is as enthusiastic as we are as we relocate our successful activities to our new venue.
